

PARTICIPANT'S RELEASE AND INDEMNITY AGREEMENT
(CITY OF MCGREGOR)

For purposes of this PARTICIPANT'S RELEASE, the term, premises, means _____ in the City of McGregor. The term, event, shall refer to _____.

In consideration of receiving permission from the City of McGregor to use the premises for the event, each of the undersigned hereby releases the City of McGregor, its elected officials, officers, employees, and representatives. (Collectively herein referred to as the City of McGregor), from any and all liability, claims, demands, lawsuits, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by any or each of the undersigned, or any property of any or each of the undersigned, while participating in the event and while in, on or upon the premises upon which the event is to occur.

Each of the undersigned, being duly aware of the risks and hazards inherent upon participating in the event and entering upon the premises, hereby elects VOLUNTARILY to participate in the event and enter upon the premises with full knowledge of the hazards and dangers associated therewith. Each of the undersigned hereby VOLUNTARILY ASSUMES ALL RISK OF LOSS, damage, or injury, including death, that may be sustained by any or each of the undersigned, or any property of any or each of the undersigned while participating in the event and while on the premises.

This PARTICIPANT'S RELEASE shall be binding upon the undersigned and each of their heirs, successors and assigns.

In signing this PARTICIPANT'S RELEASE, each of the undersigned hereby acknowledges and represents:

- A. That he or she has read this PARTICIPANT'S RELEASE.
- B. That he or she understands this PARTICIPANT'S RELEASE.
- C. That he or she signed it VOLUNTARILY.
- D. That he or she is an adult, or I am 18 years of age or older.
- E. In the case of an adult signing for a minor, the undersigned represents that he or she is the parent, next friend and guardian for the minor whose name is shown below and has full and complete authority to sign this PARTICIPANT'S RELEASE on behalf of the minor.
- F. That he or she understands the City of McGregor, and the owners and possessors of the premises upon which the event is to occur, are not responsible for any loss, damage, or injury, including death, that may be sustained by any or

each of the undersigned while participating in the event and entering upon the premises.

As further consideration for the permission granted the undersigned, and each of us, will protect, defend, and indemnify the City of McGregor from and against all loss, costs, damage and expenses occasioned by, or arising out of any accident or other occurrence, causing or inflicting injury or damage to any person or property, arising out of the event, including the use of the premises for the event, by Participant or any person claiming through or under Participant.
